As a novelty, the Integrated Annual Report 2023 included a series of indicators from the European Sustainability Reporting Standards (ESRS) on the three ESG domains (governance, social and environment), according to Directive (EU) 2022/2464 (Corporate Sustainability Reporting Directive) and the normative acts of transposition into Romanian legislation (Order of the Minister of Public Finance 85/2024).

This report also includes a brief description of the business model as well as financial and non-financial key performance indicators, with regard to economic, social and environmental aspects, such as: health and safety of patients and consumers, respect for human rights, combating corruption and bribery, risk management, but also specific indicators such as access to medicines or pharmacovigilance.

Besides those above-mentioned, the document includes the reporting of the EU Taxonomy in accordance with the six environmental objectives, according to the Regulation (EU) 2020/852 of the European Parliament and of the Council, on setting a framework to facilitate sustainable investments, with the subsequent additions brought by the Regulation (EU) 2139/2021, Regulation (EU) 2178/2021 and Regulation (EU) 1214/2022, Regulation (EU) 2485/2023 - Regulation (EU) 2486/2023, which amends Regulation (EU) 2178/2021.

The report integrates the principles of the Bucharest Stock Exchange on the ESG reporting.
